3rd Party Website Operators

The Children's Online Privacy Protection Act (COPPA) is a federal law governing the online collection of personal information from children under 13. The rules spell out what a website operator must include in a privacy policy, when and how to seek verifiable consent from a parent and what responsibilities an operator has to protect children's privacy and safety online. FWCD utilizes several educational software applications and web-based services that are operated by third parties. In order for our students to use these valuable programs and services, certain personal identifying information, generally the student's name and username and/or email address, must be provided to the website operator. Under federal law, these websites must provide parental notification and obtain parental consent before collecting personal information from children under the age of 13. The law permits schools to consent to the collection of personal information on behalf of all of its students, eliminating the need for individual parental consent given directly to the website operator. A list of applications and websites that may be used in classrooms, with links to their privacy policies and terms of service, is available on the FWCD website.

Fort Worth Country Day may, on occasion, act as agents for parents under the COPPA legislation in order to contract with third-party website operators for the benefit of our students and the school. Fort Worth Country Day considers it a Best Practice to disclose to parents those websites, and software applications, frequently used by enrolled students.

The sites or services listed below are currently used by students at Fort Worth Country Day. Others might be utilized during the school year whether listed or not. This list is updated annually.
