

## WE ARE PLEASED TO REPORT TO YOU ON THE STATUS OF THE ST. GEORGE'S SCHOOL FOUNDATION'S HOLDINGS, AS WELL AS OUR ACCOMPLISHMENTS OVER THE LAST FISCAL YEAR.

The School's endowment funds are held by the above named Foundation, which is incorporated under the Society Act in British Columbia, and is a tax-exempt, registered charitable organization and public foundation under the Income Tax Act in Canada. The objective of the Foundation is the advancement of education through the provision of classroom and athletic facilities, scholarships and bursary assistance, and fundraising for capital projects to benefit St. George's School Society.



The Foundation's fiscal year runs from July 1 to June 30, and as of June 30, 2016 the total of the named and general endowments held by the Foundation was \$15,856,303. This is an increase of \$784,247 over the previous year. The holdings in the foundation have more than doubled since 2008 through investment strategies as well as new donations. The market value of all invested endowment funds at June 30, 2016 was \$21,500,832 and the return on the investments in our last fiscal year (July 1, 2015 – June 30, 2016) was 1.0%.

During the year, 50 students received financial aid in the amount of \$847,646 and \$20,944 was awarded through scholarships in a wide variety of areas to many other students. St. George's also awarded \$240,775 in entrance scholarships during the year. This is a very significant accomplishment for the School, made possible through the support of many generous donors over the decades. In an ideal world, the ability to pay will not be a barrier for a boy to attend Saints, as far as we are able to make it possible

Some of the ways in which the income generated from our endowment funds has been used include:

- Students receiving financial assistance towards the cost of attending Saints in varying amounts from partial to full tuition.
- Provide some students with entrance scholarships.
- 28 students were celebrated with scholarships for their leadership and accomplishments.
- Specialized instruction, coaching, tours and development clinics were paid for in a wide variety of varsity and recreational athletic programs.
- Arts week speakers at both Campuses. (Partial funding)
- Support for the Visual Arts Program.
- 1.5 blocks of teaching relief and 0.2 of a block of support was provided in order to support the Global Perspectives initiatives, including environmental sustainability, in the Senior School, bringing it to 1.7 blocks of support through endowment funding.

As we continue the journey towards our vision of being **Canada's World School for Boys**, it will become increasingly important to recruit the best and the brightest students from British Columbia, Canada, and the world. The best and the brightest do not always have the resources to attend Saints, and it is the ability to offer bursaries to these boys that the endowment funds make possible. Our hope is to continue to build the St. George's Endowment Funds in order to increase the amount of financial aid offered each year to deserving boys, as well as to continue to support teaching and learning.
